\* IPCC - **Intergovernmental Panel on Climate Change** (IPCC) is the international body for assessing the science related to climate change. IPCC assessments provide a scientific basis for governments at all levels to develop climate-related policies, and they also underlie negotiations within the framework of the United Nations Framework Convention on Climate Change (UNFCCC). IPCC assessments are written by hundreds of leading scientists. Thousands of other experts contribute to the reports by acting as reviewers, ensuring the reports reflect the full range of views in the scientific community. The IPCC works by assessing published literature. IPCC currently has 195 members, including, Estonia, Latvia and Lithuania. More information: <http://www.ipcc.ch/>

- **The IPCC Working Group I (WG I)** assesses the physical scientific aspects of the climate system and climate change.
- **The IPCC Working Group II (WG II)** assesses the vulnerability of socio-economic and natural systems to climate change, negative and positive consequences of climate change, and options for adapting to it.
- **The IPCC Working Group III (WG III)** assesses options for mitigating climate change through limiting or preventing greenhouse gas emissions and enhancing activities that remove them from the atmosphere.
